- OPERATOR'S PERMIT: OPERATORS OF LARGE MAXI TAXIS SHOULD POSSESS OPERATOR'S PERMIT TO OPERATE MAXI TAXIS OF ANY CLASS. PLEASE NOTE THAT THE OPERATOR'S PERMIT MUST CLEARLY SHOW THE RELEVANT AND AUTHORIZED SIGNATURE AND STAMP.
- VALID DEFENSIVE DRIVING CERTIFICATE FOR ALL NOMINATED DRIVERS:
- VALID TAXI BADGE;
- NATIONAL IDENTIFICATION CARD:
 - VALID DRIVER'S LICENCE: AND
 - ANY OTHER RELEVANT DOCUMENTS, AS REQUIRED
