If the utility bill or Lease/Rental Agreement is not in the Applicant's name, a letter from the owner confirming the Applicant's residence and copy of the owner's national identification (ID) **MUST** be submitted.

(3) If Applicant is a Company, the application must be supported by Company validation documents such as a copy of the company/business registration certificates and/or Notice of Directors.
