MADE BY THE MINISTER UNDER SECTION 88D OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT AND SUBJECT TO THE NEGATIVE RESOLUTION OF PARLIAMENT

THE MOTOR VEHICLES AND ROAD TRAFFIC (AMENDMENT TO THE NINTH SCHEDULE) (NO. 2) ORDER, 2024

 - (ii) in the Fourth Column, by deleting the word "3" and substituting the word "2";
 - (g) in item 33, in the Fourth Column, by deleting the word "3" and substituting the word "2";
 - (h) in item 41, in the Fourth Column, by deleting the word "3" and substituting the word "2"; and
 - (i) by inserting after item 96, the following items:
