The contract will be awarded in accordance with the pre-defined evaluation criteria and scoring system outlined in the Solicitation Documents. The services to be provided will be governed by the terms and conditions outlined in the respective Solicitation Documents.

Solicitation Documents must be accompanied by the following

- Valid Income Tax and Value Added Tax Clearance Certificates or letters of exemption issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender. (Applicable to local firms only).
- A Valid Certificate of Compliance issued in accordance with the National Insurance Act. (Applicable to local firms only).

It is to be noted that failure to include the aforementioned statutory documents or letters of exemption, shall result in tender submissions being deemed as invalid and the MOWT shall not proceed with the evaluation of your tender submission having not met this requirement. Tender Bids will be accepted from Contractors registered and pre-qualified on the **Office of the Procurement Regulation (OPR), Procurement Depository**.
