Tenders must be accompanied by valid:

(i) Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.

(ii) Certificate of Compliance issued in accordance with the National Insurance Act.

The original and two (2) copies of the tender should be placed in sealed envelopes addressed to the Chairman, Permanent Secretary Tenders Committee and clearly marked on the outside:

Late tenders will not be considered in any circumstances.
