The National Infrastructure Development Company Limited (NIDCO), on behalf of the Government of the Republic of Trinidad and Tobago (GORTT), requires a Cargo Vessel to be engaged on a Time Charter for a period of two (2) years with an option to renew for an additional year.

Length Overall:	160m (maximum)
Beam:	24m
Draught:	5.5m (maximum)
Dead Weight Tonnage:	5,000 tons
Cargo Capacity:	Approximately 2000 lane meters for about 200 commercial vehicles and 20 TEU flatbeds, also with Ten (10) Reefers
Service Speed:	18 to 20 knots (maximum transit time of 5 hours to be achieved over a distance of 91NM).
Cargo Decks -Design Loads:	UDL- 2.5 t/m² Axle load – 19 t
Age:	Preferably no older than 15 years
Ramp:	Stern Ramp only – 22m – designed for axle load of 19 tons per axle
Clearance:	Above Deck Clearance – 5m (min.)

- Cabins for crew members
- Mix of public seating and cabins for 250 passengers
- Area for vending machines for passenger
