## NOTICE OF LAND LIKELY TO BE REQUIRED FOR A PUBLIC PURPOSE

## ORDER

NOTICE is hereby given that it appears to the President that the parcels of land described in the Schedule and situate in the County of Victoria and the County of St. Patrick, are lands likely to be needed for a purpose, which in the opinion of the President is a public purpose, namely: the conduct of repair works to six (6) landslips under Phase 2A of the Landslip Repair Programme of the Ministry of Works and Transport.

## SCHEDULE

Eight (8) parcels of land situate in the County of Victoria and the County of St. Patrick, and further described as follows:
